Dear Mr. Amicone:

This letter concerns your Freedom of Information Act (FOIA) request dated 10/24/2019, and received in this Office on 10/24/2019, for records pertaining to biographical data of Joseph Bevilacqua. This response is made on behalf of the American Battle Monuments Commission.

Specifically, you requested:

- “Joseph Bevilacqua’s Biographical Data Sheet (attached file) without censorship. I ask the ABMC to remove not all the censorship from the Bevilacqua’s bio, but only the censorship on:
 1. “Prior government agencies”, because FOIA allows the information “Past and present agencies” to be released to the public;
 2. The location of the American Cemetery of Sicily-Rome, because it is an open information.”

Please be advised that a search has been conducted within the agency of paper and digital records. I have determined 1 page of material is appropriate for release without excision and a copy is enclosed.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
